WHAT IS THIS PRODUCT?

The risk indicator assumes you keep the product until 1 December 2021. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. We have classified this product as 5 out of 7, which is a medium-high risk class.
