### This investment may be right for you if:-

- You are a **retail investor with an advanced level of knowledge regarding the financial markets and financial instruments AND understand the specific factors including the risks highlighted in the literature provided to you AND you also have previous experience of investing in products like this one.**
- You are looking for **income paid Semiannually**, linked to the performance of the **underlying assets (AT&T, Vale SA, Pfizer, VanEck Vectors Gold Miners ETF, Freeport-McMoRan, Advanced Micro Devices)**
- You understand that on **Semiannually** basis, on any given observation date, **if any one of the underlying assets is below the product of the corresponding coupon barrier price and their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least **the product of the corresponding coupon barrier price and its initial level** and the other underlying assets in the basket are at or above **the product of the corresponding coupon barrier price and their initial level** the previous missed coupons will be paid including any other coupon due.
