You are about to purchase a product that is not simple and may be difficult to understand.

What is the Product?

Objective

The product is designed to provide a return in the form of (1) conditional coupon payments and (2) cash payments, both depending on the occurrence of credit events in respect of reference entities within the term of the product. The product has a fixed term and will terminate on the **maturity date** (as defined below), unless terminated early. If within the term of the product in respect of at least one of the **reference entities** (as defined below) the **credit event** (as defined below) or hedging disruption occur and the Credit Event Notice or Hedging Disruption Notice or Obilgation early redemption notice is served upon you, both Notional and the coupon payments to be paid will decrease. Coupon. 
