# What is the Product?

### Туре

Cyprus law governed over-the-counter (OTC) credit derivative transaction linked to the credit risk of the reference entities those set out below. # Objective

The product is designed to provide a return in the form of (1) conditional coupon payments and (2) cash payments, both depending on the occurrence of credit events in respect of reference entities within the term of the product. The product has a fixed term and will terminate on the **maturity date** (as defined below), unless terminated early. 

### How long should I hold it and can I take money earlier?

Recommended holding period: 59 months

The product aims to provide you with the return described under "What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until the maturity date.
