This investment may be right for you if:-

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you.**
- You are looking for **income paid Semiannually**, linked to the performance of the **underlying assets (Royal Caribbean Cruises Ltd BioMarin Pharmaceutical Inc Ringcentral Inc Uber Technologies Inc Western Digital Corp.)**
- You understand that on a Semiannually basis, on any given observation date, **if any one of the underlying assets is below 70,70% of their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least 70,70% of its initial level and the other underlying assets in the basket are at or above 70,70% of their initial level the previous missed coupons will be paid including any other coupon due
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive shares at the equivalent amount to the worst performing asset.** For instance on a \$10,000 investment, if the worst performing underlying asset fell 60%, you would receive 40% of their initial investment back (\$4,000) in the form of shares
- **You understand that on a Semiannually basis on any given observation date if all underlying assets are at or above their Second Strike Price, the product will redeem early, and return the initial capital to you, including any coupons due**
