# You are about to purchase a product that is not simple and may be difficult to understand.

## What is the Product?

## Objective

The product is designed to provide a return in the form of (1) conditional coupon payments and (2) a cash payment depending on the **worst performing share** current price as of Redemption Valuation Date (as defined below) on termination of the product. 
