You are about to purchase a product that is not simple and may be difficult to understand.

What is the Product?

Cyprus law governed over-the-counter (OTC) credit derivative transaction linked to the credit risk of the reference entities those set out below. Objective

The product is designed to provide a return in the form of (1) conditional coupon payments and (2) cash payments, both depending on the occurrence of credit events in respect of reference entities within the term of the product. The product has a fixed term and will terminate on the **maturity date** (as defined below), unless terminated early. If within the term of the product in respect of at least one of the **reference entities** (as defined below) the **credit event** (as defined below) or hedging disruption occur and the Credit Event Notice or Hedging Disruption Notice or Obilgation early redemption notice is served upon you, both Notional and the coupon payments to be paid will decrease. Coupon. How long should I hold it and can I take money earlier?

Recommended holding period: 58 months

The product aims to provide you with the return described under "What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until the maturity date.

You, however, have an option to terminate the product early. In case you do so you will, within 5 (five) business days upon the proposed early termination date receive the **early termination amount** equal to 85% of the multiple of notional and reference obligation with the lowest ration between the current value and par value.
