You are about to purchase a product that is not simple and may be difficult to understand.

What is the Product?

Type

Objective

The product is designed to provide a return in the form of a cash payment depending on the **basket performance value** as of Redemption Valuation Date (as defined below) on termination of the product. The product has a fixed term and will terminate on the **maturity date** (as defined below), unless terminated early. 

How long should I hold it and can I take money earlier?

Recommended holding period: 12 months

The product aims to provide you with the return described under "What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until the maturity date.
