You are about to purchase a product that is not simple and may be difficult to understand.

What is the Product?

Cyprus law governed over-the-counter (OTC) equity derivative transaction linked to the worst performing share among those set out below with 'autocall' and 'memory coupon' features. Under the applicable laws and regulations of the Republic of Cyprus it may be required for you to enter into OTC derivative transactions with Brokercreditservice Structured Products Plc through a duly authorized and regulated investment firm BrokerCreditService (Cyprus) Ltd acting as agent for and on your behalf (**intermediary**). Objective

The product is designed to provide a return in the form of (1) conditional coupon payments and (2) a cash payment or delivery of the **worst performing share** (as defined below) on termination of the product. The timing and amount of these payments will depend on the performance of the underlying shares. The product has a fixed term and will terminate on the **maturity date** (as defined below), unless terminated early. If, at maturity, the worst performing share's **current price** (as defined below) has fallen *below* 79% of its **initial price** (as defined below), you will receive the worst performing share in its **delivery volume** (as defined below) and, consequently, *LOSE UP TO YOUR ENTIRE INVESTMENT*.

Coupon. If on any **event determination date** (as defined below) the worst performing share's current price *is at or above* 79% of its initial price you will, within two (2) business days following that event determination date, receive a **coupon** equal to 20% per annum on the amount of your investment calculated for the period starting from the immediately preceding event determination date or, in respect of the first coupon, **valuation date** (as defined below) plus any unpaid coupon(s) for the previous period(s). *Early termination following an autocall*. 

How long should I hold it and can I take money earlier?

Recommended holding period: 60 months

The product aims to provide you with the return described under "What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until the maturity date.

You, however, have an option to terminate the product early. In case you do so you will, within 5 (five) business days upon the proposed early termination date receive the **early termination amount** equal to 65% of the Notional multiplied by the lesser of (a) one; or (b) the ratio between the Worst Performing Share's Current Price and 113% of its initial value. The Brokercreditservice Structured Products Plc may at its own discretion increase the Early Termination Amount.
