This investment may be right for you if:-

- You are a **retail investor with an advanced level of knowledge regarding the financial markets and financial instruments AND understand the specific factors including the risks highlighted in the literature provided to you AND you also have previous experience of investing in products like this one.**
- You are looking for **income paid Quarterly**, linked to the performance of the **underlying assets (Abiomed Inc Applied Materials Inc Gilead Sciences Inc Square Inc Weibo Corp)**
- You understand that on a Quarterly basis, on any given observation date, **if any one of the underlying assets is below 78,4% of their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least 78,4% of its initial level and the other underlying assets in the basket are at or above 78,4% of their initial level the previous missed coupons will be paid including any other coupon due
