This investment may be right for you if:-

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you.**
- You are looking for **income paid Quarterly**, linked to the performance of the **underlying assets (ViacomCBS Inc Chewy Inc Helmerich & Payne Inc MMC Norilsk Nickel PJSC Royal Caribbean Cruises Ltd Roku Inc)**
- You understand that on a Quarterly basis, on any given observation date, **if any one of the underlying assets is below 65,00% of their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least 65,00% of its initial level and the other underlying assets in the basket are at or above 65,00% of their initial level the previous missed coupons will be paid including any other coupon due
