- You are looking for **income paid Quarterly**, linked to the performance of the **underlying assets (Alibaba Group Holding Ltd Baidu Inc Discovery Inc Class A Pinduoduo Pinterest Inc Tencent Music Entertainment Group)**
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the amount of the product of the Current Price of the Worst Performing Share and the Volume within 5 Business Days from the Maturity Date. The Volume shall be calculated as the Notional divided by the Initial Price of the Worst Performing Share rounding down to the nearest whole number. For instance on a \$10,000 investment, if the worst performing underlying asset fell 60%, you would receive 40% of their initial investment back (\$4,000).**
- **You understand that on a Quarterly basis on any given observation date if all underlying assets are at or above their Autocall Price, the product will redeem early, and return the initial capital to you, including any coupons due**
