- You are looking for **income paid Quarterly**, linked to the performance of the **underlying assets (Pinterest Inc Discovery Inc Class A Zillow Group Inc Ringcentral Inc Wynn Resorts Limited)**
- You understand that on a Quarterly basis, on any given observation date, **if any one of the underlying assets is below 55,00% of their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least 55,00% of its initial level and the other underlying assets in the basket are at or above 55,00% of their initial level the previous missed coupons will be paid including any other coupon due
