### This investment may be right for you if:-

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you.**
- You are looking for **income paid Semiannually**, linked to the performance of the **underlying assets (Carnival Corporation Beyond Meat Inc Boeing Co/The Vale SA ADR Intel Corp )**
- You understand that on a Semiannually basis, on any given observation date, **if any one of the underlying assets is below 70,00% of their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least 70,00% of its initial level and the other underlying assets in the basket are at or above 70,00% of their initial level the previous missed coupons will be paid including any other coupon due
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the amount of the product of the Current Price of the Worst Performing Share and the Volume within 5 Business Days from the Maturity Date.** The Volume shall be calculated as the amount of the initial investment divided by the Initial Price of the Worst Performing Share rounding down to the nearest whole number. For instance on a \$10,000 investment, if the worst performing underlying asset fell 60%, you would receive 40% of their initial investment back (\$4,000).
- **You understand that on a Semiannually basis on any given observation date if all underlying assets are at or above their Autocall Price, the product will redeem early, and return the notional amount to you, including any coupons due**
- You may be looking to re-invest capital from previous Structured Product Investments which have matured or are about to mature
