This investment may be right for you if:-

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you.**
- You are looking for **income paid Annually**, linked to the performance of the **underlying assets (Unity Software Inc Carnival Corporation Antero Resources Corp Advanced Micro Devices Inc iQIYI Inc Biogen Inc)**
- You understand that on a Annually basis, on any given observation date, **if any one of the underlying assets is below 75,00% of their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least 75,00% of its initial level and the other underlying assets in the basket are at or above 75,00% of their initial level the previous missed coupons will be paid including any other coupon due
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the amount of the product of the Current Price of the Worst Performing Share and the Volume within 5 Business Days from the Maturity Date.** The Volume shall be calculated as the notional amount divided by the Initial Price of the Worst Performing Share rounding down to the nearest whole number. For instance on a \$10,000 investment, if the worst performing underlying asset fell 60%, you would receive 40% of their initial investment back (\$4,000).
- **You understand that on a Annually basis on any given observation date if all underlying assets are at or above their Autocall Price, the product will redeem early, and return the notional amount to you, including any coupons due**
