- You are looking for **income paid Quarterly following the valuation date, linked to the performance of the underlying assets General Motors, Royal Caribbean Cruises Ltd, Advanced Micro Devices, Vale SA, Nvidia Corp, Pfizer.**
- You understand that on a **Quarterly** basis, on any given observation date, unconditionally you will receive the coupon payment.
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the amount of the product of the Current Price of the Worst Performing Share and the Volume within 5 Business Days from the Maturity Date. The Volume shall be calculated as the Notional divided by the product of the price coefficient and the Initial Price of the Worst Performing Share rounding down to the nearest whole number.**
- **You understand that on a Quarterly basis on any given observation date if all underlying assets are at or above their Autocall Price, the product will redeem early, and return the initial capital to you, including coupons and other payments that may be due**
