### This investment may be right for you if:-

- You are a **retail investor with an advanced level of knowledge regarding the financial markets and financial instruments AND understand the specific factors including the risks highlighted in the literature provided to you AND you also have previous experience of investing in products like this one.**
- You are looking for **income paid Every four months**, linked to the performance of the **underlying assets (Beyond Meat Inc., Shopify, Halliburton Co, Vale SA, Farfetch Ltd, Zoom Video Communications Inc)**
