### This investment may be right for you if:-

- You are a **retail investor with an advanced level of knowledge regarding the financial markets and financial instruments AND understand the specific factors including the risks highlighted in the literature provided to you AND you also have previous experience of investing in products like this one.**
- You are looking for **income paid Quarterly**, linked to the performance of the **underlying assets (Chewy Inc, Amazon, Xpeng Inc, Barrick Gold Corp, CF Industries Holdings, Lyft Inc)**
