- You are looking for **income paid Monthly following the valuation date, linked to the performance of the underlying assets Farfetch Ltd, The Kraft Heinz Company, Lucid Group Inc, Shopify, Snap Inc, Vale SA.**
- You understand that on a **Monthly** basis, on any given observation date, unconditionally you will receive the coupon payment.
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the amount of the product of the Current Price of the Worst Performing Share and the Volume within 5 Business Days from the Maturity Date. The Volume shall be calculated as the Notional divided by the product of the price coefficient and the Initial Price of the Worst Performing Share rounding down to the nearest whole number.**
