- You are looking for **income paid Quarterly following the valuation date, linked to the performance of the underlying assets Ford Motor Company, Microsoft Corporation, Pfizer, AT&T, Li Auto Inc.**
- You understand that on a **Quarterly** basis, on any given observation date, unconditionally you will receive the coupon payment.
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the amount of the product of the Current Price of the Worst Performing Share and the Volume within 5 Business Days from the Maturity Date.
