- You are a **retail investor with an advanced level of knowledge regarding the financial markets and financial instruments AND understand the specific factors including the risks highlighted in the literature provided to you AND you also have previous experience of investing in products like this one.**
- You are looking for **income paid Monthly following the valuation date, linked to the performance of the underlying assets PBF Energy Inc., Xpeng Inc, Lyft Inc, Lucid Group Inc, Shopify, Affirm Holdings, Inc..**
