- You are looking for **income paid Annually following the valuation date, linked to the performance of the underlying assets Li Auto Inc, Tesla, Xpeng Inc.**
- You understand that on **Annually** basis, on any given observation date, **if any one of the underlying assets is below the product of the corresponding coupon barrier price and their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least **the product of the corresponding coupon barrier price** and its initial level and the other underlying assets in the basket are at or above **the product of the corresponding coupon barrier price** and their initial level the previous missed coupons will be paid including any other coupon due
