- You are looking for **income paid Semiannually**, linked to the performance of the **underlying assets (CF Industries Holdings, Snap Inc, Schlumberger, Lyft Inc, Li Auto Inc) and** to the credit risk of the **reference entities (Jaguar Land Rover Automotive PLC)**
