- You understand that on a **Semiannually** basis, on any given coupon payment date, **if you receive the credit event notice regarding any of the reference entities, there will be no coupon for this payment period or it will be decreased.**
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the part of the notional amount.** The magnitude of a loss is represented by the amount of the reference entities that are subject to the credit events.
- You may be looking to re-invest capital from previous Structured Product Investments which have matured or are about to mature
