- You are looking for **income paid Semiannually**, linked to the performance of the **underlying assets (Schlumberger, Unity Software Inc, Pinduoduo Inc, CF Industries Holdings, Li Auto Inc, Macy's)** and to the credit risk of the **reference entities (Nissan Motor Acceptance Co)**
