WHAT IS THIS PRODUCT?

TYPE The product is in the form of a debt instrument.

OBJECTIVES To provide you with exposure to the performance of the Underlying(s), whilst providing for a minimal return of the Nominal Amount at maturity (subject to the credit risk of the Manufacturer). Amounts stated below are in respect of each Nominal Amount that you invest.

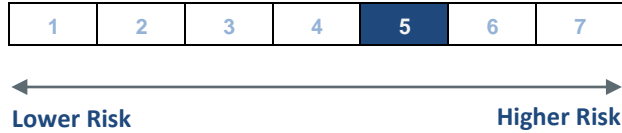
Early redemption and adjustments

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?**SUMMARY RISK INDICATOR**

The risk indicator assumes you keep the product until 1 August 2022. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because BCS is not able to pay you. We have classified this product as 5 out of 7, which is a medium-high risk class. This classification takes into consideration two elements: 1) the market risk - that rates the potential losses from future performance at a medium-low level; and 2) the credit risk which estimates that poor market conditions will likely impact the capacity of Brokercreditservice Structured Products Plc to pay you. **Be aware of currency risk.
