### This investment may be right for you if:-

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you.**
- You are looking for **income paid Every four months**, linked to the performance of the **underlying assets (Albemarle, Tencent Music Entmt Group, Xpeng Inc, Tesla, Li Auto Inc)**
- You understand that on **Every four months** basis, on any given observation date, unconditionally you will receive the coupon payment.
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the amount of the product of the Notional and the Protection Level rounding down to the nearest whole number within 5 Business Days from the Maturity Date.** For instance on a \$10,000 investment, if the Protection Level is 60%, you would receive 60% of their initial investment back (\$6,000).
