- You are looking for **income paid Quarterly following the valuation date, linked to the performance of the underlying assets Enphase Energy Inc, The Kraft Heinz Company, Lucid Group Inc, Lyft Inc, Snap Inc, Xpeng Inc.**
- You understand that on a **Quarterly** basis, on any given observation date, **if any one of the underlying assets is below the product of the corresponding coupon barrier price and their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least **the product of the corresponding coupon barrier price and** its initial level and the other underlying assets in the basket are at or above **the product of the corresponding coupon barrier price and** their initial level the previous missed coupons will be paid including any other coupon due
