- You are looking for **income paid Monthly following the valuation date, linked to the performance of the underlying assets Airbnb Inc, Alphabet, Barrick Gold Corp, Netflix, Delta Air Lines.**
- You understand that on a **Monthly** basis, on any given observation date, unconditionally you will receive the coupon payment.
