## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to purchase a product that is not simple and may be difficult to understand.**

## What is the Product?

### Type

Cyprus law governed over-the-counter (OTC) equity derivative transaction linked to the worst performing share among those set out below with 'autocall' and 'memory coupon' features. Forms of contract documentation governing this type of transactions can be found at: <http://bcs-sp.com/otc/>. You may invest not less than USD 518500 in the product.

Under the applicable laws and regulations of the Republic of Cyprus it may be required for you to enter into OTC derivative transactions with Brokercreditservice Structured Products Plc through a duly authorized and regulated investment firms (including BrokerCreditService (Cyprus) Ltd or BCS Capital (DIFC) Limited) acting as agent for and on your behalf (**intermediary**). Brokercreditservice Structured Products Plc does not guarantee that any intermediary will agree to act for and on your behalf in entering into any such transactions.

### Objective

The product is designed to provide a return in the form of (1) unconditional coupon payments and (2) a cash payment depending on the realization of the credit risk of the **reference entities** (as defined below). The timing and amount of these payments will depend on the performance of the underlying shares. The product has a fixed term and will terminate on the **maturity date** (as defined below), unless terminated early. If, at redemption valuation date or earlier, you receive the credit event notice regarding at least 1 of the reference entities, you will receive the part of notional based on the price of the reference bond and, consequently, **LOSE UP TO YOUR ENTIRE INVESTMENT**.

**Coupon.** If on any **event determination date** (as defined below) the worst performing share's current price *is at or above* Coupon Barrier Price N of its initial price you will, within two (2) business days following that event determination date, receive a **coupon** equal to coupon rate N on the amount of your investment calculated for the period starting from the immediately preceding event determination date or, in respect of the first coupon, **valuation date** (as defined below) plus any unpaid coupons at Coupon Rate N for the previous period(s) multiplied by Snowball Coefficient (if no coupon rates were paid on the previous periods).

**Early termination following an autocall.** The product will terminate prior to the maturity date if, on any event determination date, the current price of the worst performing share *is at or above* Autocall price, stated for the particular **event determination date below**. In such case, you will, within two (2) business days following that event determination date, receive, in addition to any final coupon, a cash payment equal to the amount of your investment, multiplied by the Autocall coefficient, stated for the particular **event determination date below**. No further payments will be made on any date after such event determination date.

**Termination on the maturity date.** If the product has not terminated early, on the maturity date, you will receive:

- (1) if the final reference level of the worst performing share is below 75% of its initial price on the redemption valuation date, the Seller shall pay to the Buyer amount of the Volume within 5 Business Days from the Maturity Date or
- (2) in other case, a cash payment equal to the amount of the Notional;

**Potential adjustment events.** If during the lifetime of the product a split, consolidation or any other event having a diluting or concentrative effect on the theoretical value of the relevant underlying share occurs the terms of the product may be correspondingly adjusted and you will be duly notified of such adjustment.

**Extraordinary events.** If during the term of the product any extraordinary event (such as nationalization, insolvency or delisting) occurs in respect of an issuer of any underlying share, such share's current price in respect of any date for the purposes of the product shall be decreased by 30%. Consequently, due to an extraordinary event you may **LOSE UP TO YOUR ENTIRE INVESTMENT**.

## Definitions

<b>Autocall coefficient:</b>	The multiplier of notional for the additional payment in case of autocall
<b>Autocall price:</b>	For each share, its initial price multiplied by autocall barrier
<b>Coupon Barrier Price N:</b>	For each share its initial price multiplied by Coupon Barrier N
<b>Current price:</b>	The closing price of an underlying share as of an event determination date, redemption valuation date or early termination valuation date
<b>Volume:</b>	In respect of each share - the amount of the Notional multiplied by the Protection Level rounding down to the nearest whole number
<b>Protection Level:</b>	90%
<b>Event determination dates:</b>	Every two months following the valuation date
<b>Initial price:</b>	The closing price of an underlying share as of the valuation date
<b>Redemption Valuation Date:</b>	23.01.2025
<b>Snowball coefficient:</b>	Multiplier for payment of coupons for previous periods, where coupons remain unpaid, in cases where the conditions for such payment are met is 1
<b>Maturity date:</b>	23.01.2025
<b>Valuation date:</b>	23.01.2024
<b>Worst performing share:</b>	For a given date, the underlying share with the worst performance between the initial price and the current price

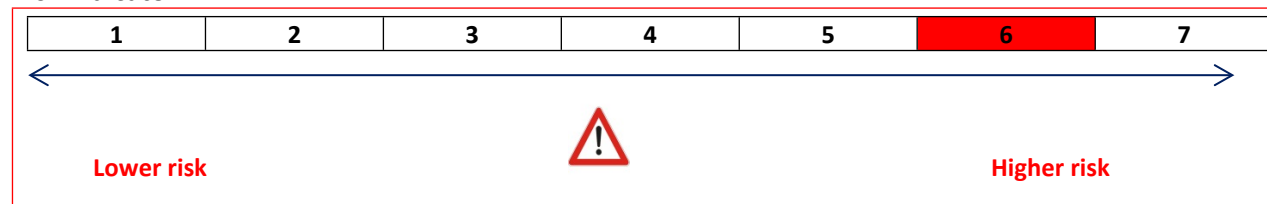
## Intended retail investor

This product is intended to be offered to retail investors who fulfil all of the criteria below:

1. they have prior experience in investing in derivative products;
2. they can understand the interaction between the conditional payments under the product and the underlying shares' market performance;
3. they can afford to have their invested capital locked in for the full term of the product;

## What are the risks and what could I get in return?

### Risk indicator

### **What are the costs?**

The costs shown in the table above represent how much the expected costs of the product would affect your return, assuming the product performs in line with the moderate performance scenario. The total costs are composed of the **early termination cost** up to 35% of the amount you invest.

### **How long should I hold it and can I take money earlier?**

**Recommended holding period:** 12 months

The product aims to provide you with the return described under “What is this product?” above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until the maturity date.

You, however, have an option to terminate the product early. In case you do so you will, within 5 (five) business days upon the proposed early termination date receive the **early termination amount** equal to 65% of the Notional multiplied by the lesser of (a) one; or (b) the ratio between the Worst Performing Share’s Current Price as of Early Termination Valuation Date and 100% of its initial value. The Brokercreditservice Structured Products Plc may at its own discretion increase the Early Termination Amount.
