- You are a **retail investor with an advanced level of knowledge regarding the financial markets and financial instruments AND understand the specific factors including the risks highlighted in the literature provided to you AND you also have previous experience of investing in products like this one.**
- You are looking for **income paid conditionally** each 90th Day starting from the Trade Date linked to the performance of the **underlying asset (MU US)**
- You understand that on a 90-day basis, on any given observation date, if Current Price of the underlying as on the relevant Event Determination Date is not more than the Current Price of the Share on the preceding Event Determination Date, **there will be no coupon for this payment period.**
