The manufacturer designed this product for a theoretical investor and suggests you liaise with the distributor to ascertain if you fit the criteria of its intended target market.

This investment may be right for you if:-

- You are a **retail investor with an advanced level of knowledge regarding the financial markets and financial instruments AND understand the specific factors including the risks highlighted in the literature provided to you AND you also have previous experience of investing in products like this one.**
- You are looking for **income paid Every two months**, linked to the performance of the **underlying assets (Advanced Micro Devices, CF Industries Holdings, The Kraft Heinz Company, Coca Cola CO, Palo Alto Networks, PayPal Holdings Inc)**
- You understand that on an **Every two months** basis, on any given observation date, **if the basket performance value is below the coupon barrier, there will be no coupon for this payment period.**
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the part of the notional amount.** The magnitude of a loss per annum is represented by risk coefficient. For instance, on a \$10,000 investment in a 3-year product, if the basket performance value is -90%, you would receive 85% of initial investment back (\$8,500) with the risk coefficient 5% p.a.
- **You understand that on an Every two months basis on any given observation date if the basket performance value is at or above their Autocall Barrier, the product will redeem early, and return the initial capital to you, including coupons and other payments that may be due**
- You may be looking to re-invest capital from previous Structured Product Investments which have matured or are about to mature
- You understand how debt-based investments work, and may already hold such investments
- You want the potential to secure an investment return above that available from a deposit-based investment and acknowledge and **accept the Summary Risk Indicator set out in the Key Information Document (KID)**
- **Accept that you could lose capital and be able to afford to do so**, if the underlying assets were to decline below coupon barrier at the end of the term of the investment period
- You understand that **in extreme circumstances you could lose all of your money** if the issuer, manufacturer or distributor were to default including if one of the underlying were to become insolvent
