What is the Product?

Type

Objective

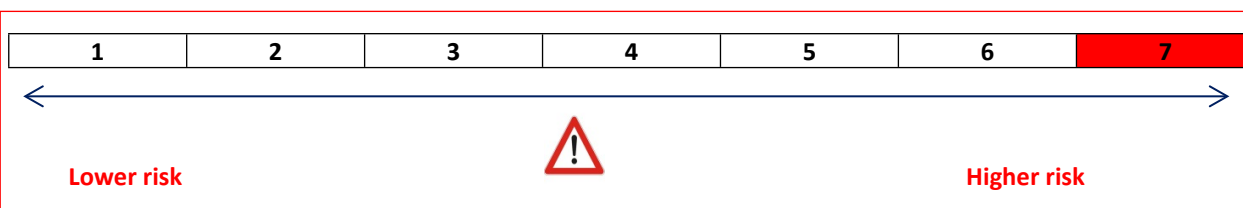
Intended retail investor

What are the risks and what could I get in return?

Risk indicator
