### This investment may be right for you if:-

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you.**
- You are looking for **income paid Quarterly**, linked to the performance of the **underlying assets (Nvidia Corp, Enphase Energy Inc, Dell Technologies Inc., Pinduoduo Inc, Moderna Inc, AppLovin Corp.)**
- You understand that on a **Quarterly** basis, on any given observation date, **if any one of the underlying assets is below the product of the corresponding coupon barrier price and their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least **the product of the corresponding coupon barrier price** and its initial level and the other underlying assets in the basket are at or above **the product of the corresponding coupon barrier price** and their initial level the previous missed coupons will be paid including any other coupon due
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the amount of the product of the Notional and the Protection Level rounding down to the nearest whole number within 5 Business Days from the Maturity Date.** For instance on a \$10,000 investment, if the Protection Level is 60%, you would receive 60% of their initial investment back (\$6,000).
- **You understand that on a Quarterly basis on any given observation date if all underlying assets are at or above their Autocall Price, the product will redeem early, and return the initial capital to you, including coupons and other payments that may be due**
