- You are looking for **income paid Quarterly**, linked to the performance of the **underlying assets (Keyence Corp Biogen Inc Cabot Oil & Gas Corp Helmerich & Payne Inc VanEck Vectors Oil Services ETF Simon Property Group Inc)**
- You understand that on a Quarterly basis, on any given observation date, **if any one of the underlying assets is below 77,7% of their initial level, there will be no coupon for this payment period**.
