- You are looking for **income paid Semiannually**, linked to the performance of the **underlying assets (Twilio Inc Helmerich & Payne Inc Wayfair Inc Abiomed Inc Alerian MLP ETF VanEck Vectors Oil Services ETF)**
- You understand that on a Semiannually basis, on any given observation date, **if any one of the underlying assets is below 74,9% of their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least 74,9% of its initial level and the other underlying assets in the basket are at or above 74,9% of their initial level the previous missed coupons will be paid including any other coupon due
