- You are looking for **income paid Quarterly**, linked to the performance of the **underlying assets (American Airlines Group Advanced Micro Devices Inc Biogen Inc )**
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive** the amount of the product of the Current Price of the Worst Performing Share and the Volume within 5 Business Days from the Maturity Date. The Volume shall be calculated as the Notional divided by the Initial Price of the Worst Performing Share rounding down to the nearest whole number. For instance on a \$10,000 investment, if the worst performing underlying asset fell 60%, you would receive 40% of their initial investment back (\$4,000).
