### This investment may be right for you if:-

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you.**
- You are looking for **income paid Every 2 months**, linked to the performance of the **underlying assets (American Airlines Group United Airlines Holdings Inc Vipshop Holdings Ltd Alibaba Group Holding Ltd Advanced Micro Devices Inc )**
- You understand that on a Every 2 months basis, on any given observation date, **if any one of the underlying assets is below 70,00% of their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least 70,00% of its initial level and the other underlying assets in the basket are at or above 70,00% of their initial level the previous missed coupons will be paid including any other coupon due
